


Properties can be let if they have an energy rating from A to E.

# **Energy rating and score**

# How this affects your energy bills

## Step 4: Double glazed windows

Replace single glazed windows with low-E double glazed windows

## Step 5: Solar photovoltaic panels, 2.5 kWp

Typical installation cost	£3,500 - £5,500
Typical yearly saving	£337
Potential rating after completing steps 1 to 5	82 B
